The Criteria for HLC Accreditation

Criterion 1. Mission

The institution's mission is clear and articulated publicly; it guides the institution's operations.

Criterion 2. Integrity: Ethical and Responsible Conduct

The institution acts with integrity; its conduct is ethical and responsible.

Criterion 3. Teaching & Learning: Quality, Resources, and Support

The institution provides high quality education, wherever and however its offerings are delivered.

Criterion 4. Teaching and Learning: Evaluation and Improvement

The institution demonstrates responsibility for the quality of its educational programs, learning environments, and support services, and it evaluates their effectiveness for student learning through processes designed to promote continuous improvement.

Criterion 5. Resources, Planning, and Institutional Effectiveness

The institution's resources, structures, and processes are sufficient to fulfill its mission, imp rove the quality of its educational offerings, and respond to future challenges and opportunities. The institution plans for the future.

Why is Accreditation Important to NDSCS, Students and You?

Accreditation means quality. That's important because it determines if a college meets or exceeds minimum standards of quality. Degrees from accredited institutions are valuable. In fact, NDSCS only accepts transfer credits from accredited institutions.

Accreditation means credibility—it separates us from many forprofit colleges. Accreditation shows that NDSCS is an institution that takes steps to ensure our programs have credibility . . . for our students, our community, and employees.

Accreditation means opportunity. Without HLC accreditation our students wouldn't get federal student aid. Without student aid many students can't afford college. Without students, we won't have a job.

Accreditation doesn't come easy and because we are an accredited institution, we are showing our community that we are and will continue to do the hard work required to make the college an important part of the community.
